Re: Canal Pointe Boulevard Road Diet

Dear Mayor Hsueh,

Regarding recent letters from Sherri Bobish of March 8, 2010 and the March 11<sup>th</sup> response letter by the West Windsor Bicycle and Pedestrian Alliance (WWBPA), the Canal Pointe Condominium Association has asked me to write this letter in support of the actions being recommended by the Alliance.

Members of the Board of Trustees and many residents of our community have witnessed, and frequently reported, incidences of pervasive speeding, unsafe conditions for pedestrians crossing, the inability to use bicycles on the roadway, and unsafe driving conditions driving on or entering Canal Pointe Boulevard. This roadway is the "life-blood" of our community and must be safe.

Many of the unsafe conditions, as described, were also mentioned in the 2004 West Windsor Bicycle/Pedestrian Plan and its resulting traffic study. The conditions have worsened recently due to new construction in Carnegie Center West, which has increased traffic on CP Boulevard. There are still large areas along the Boulevard, currently undeveloped, that have been cited for future development, which will cause even more traffic.

In addition to the recent and future development traffic, the rapid deterioration of the Boulevard's road surface has caused an added safety hazard from vehicles that must swerve to miss the numerous potholes, which recently have begun to emerge.

Please consider this letter as a plea to prevent any future tragedy caused by the many unsafe conditions referenced in this letter. It is not too soon to begin implementing the recommended "Road Diet" offered by the WWBPA. We believe that this may be the answer to a safer community.
